

Information about your Animals

The judging program is divided into classes. Your animals will be eligible for a single class dependent on their sex and age. All classes are shown in the enclosed Schedule, but some special classes, such as Championship, do not require you to nominate your animal.

Information about the Show

- Time:** Animals must be penned at the Showground by 8.30am Thursday 22 February 2018 and may not leave until 5pm Sunday 25 February 2018. ANIMALS ENTERED IN THE STEERS/HEIFERS HOOF & HOOK COMPETITIONS MUST BE PENNED BY 12 NOON WEDNESDAY 21 FEBRUARY 2018.
- Cost:** Entry fees are \$110 for each class, except where as specified. A 20% discount on total entry fees is offered to RNCAS members. You must be a current financial member to claim this discount. Associate or Junior memberships are not eligible.
- Conditions:** You must not bring to the Showground an animal which is sick, diseased or intractable. You must present every animal in its natural conformation and without use of any hormones or prohibited drugs.
